1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 18-12-214, **amend**  
3 (3) (b) as follows:

4 **18-12-214. Authority granted by permit - carrying**  
5 **restrictions.** (3) A permit issued pursuant to this part 2 does not  
6 authorize a person to carry a concealed handgun onto the real property,  
7 or into any improvements erected thereon, of a public elementary, middle,  
8 junior high, or high school; except that:

9 (b) A permittee who is employed or retained by contract by a  
10 school district OR CHARTER SCHOOL as a school security officer may carry  
11 a concealed handgun onto the real property, or into any improvement  
12 erected thereon, of a public elementary, middle, junior high, or high  
13 school while the permittee is on duty;

14 **SECTION 2. Safety clause.** The general assembly hereby finds,  
15 determines, and declares that this act is necessary for the immediate  
16 preservation of the public peace, health, and safety.
