1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 2-3-1901, **repeal**  
3 (2)(b), (2)(c), and (2)(d) as follows:

4 **2-3-1901. Legislative oversight committee for Colorado jail**  
5 **standards - creation - duties - repeal. (2) Duties. (b)** ~~The committee~~  
6 ~~is responsible for the oversight of the commission. The chair of the~~  
7 ~~committee shall establish organizational rules and procedural rules as are~~  
8 ~~necessary for the operation of the commission.~~

9 ~~(c) The committee may introduce up to a total of three bills, joint~~  
10 ~~resolutions, or concurrent resolutions during the 2024 legislative session.~~  
11 ~~Bills that the committee introduces are exempt from the five-bill~~  
12 ~~limitation specified in rule 24 (b)(1)(A) of the joint rules of the senate and~~  
13 ~~the house of representatives. Joint resolutions and concurrent resolutions~~  
14 ~~that the committee introduces are exempt from the limitations set out in~~  
15 ~~rule 26 (g) of the rules of the house of representatives and rule 30 (f) of~~  
16 ~~the rules of the senate. The committee is exempt from the requirement to~~  
17 ~~report bills or other measures to the legislative council as specified in rule~~  
18 ~~24 (b)(1)(D) and rule 24A (d)(8) of the joint rules of the senate and the~~  
19 ~~house of representatives and in section 2-3-303 (1)(f), Colorado Revised~~  
20 ~~Statutes. The committee is subject to rule 24A of the joint rules of the~~  
21 ~~senate and house of representatives, except to the extent that the rule may~~  
22 ~~conflict with this part 19. Bills recommended by the committee must be~~  
23 ~~introduced by the introduction deadline for house bills specified in rule~~

1     ~~23 (a)(1) of the joint rules of the senate and house of representatives. The~~  
2     ~~chair and vice-chair shall jointly establish the last date for the meeting at~~  
3     ~~which the committee may approve bill requests, the last date by which~~  
4     ~~committee members must finalize bill drafts or by which bill drafts will~~  
5     ~~be deemed finalized for fiscal note purposes, and the last date by which~~  
6     ~~the committee will consider and take final action on bill drafts.~~

7             ~~(d) The committee shall receive and approve the report of the~~  
8     ~~commission required by section 2-3-1903 (2).~~

9             **SECTION 2.** In Colorado Revised Statutes, 7-90-1003, **amend**  
10     (1) introductory portion and (1.5) introductory portion as follows:

11            **7-90-1003. Articles of reinstatement.** (1) To reinstate under this  
12     part 10 an entity that has been dissolved for fewer than two years, an  
13     individual named in the articles of ~~restatement~~ REINSTATEMENT shall  
14     deliver articles of reinstatement to the secretary of state for filing pursuant  
15     to part 3 of this article 90 stating:

16            (1.5) To reinstate under this part 10 an entity that has been  
17     dissolved for two years or longer or for which the period of dissolution  
18     is not known based on the records of the secretary of state, an individual  
19     named in the articles of ~~restatement~~ REINSTATEMENT shall deliver to the  
20     secretary of state for filing pursuant to part 3 of this article 90 the  
21     following documents:

22            **SECTION 3.** In Colorado Revised Statutes, 8-20.5-103, **repeal**  
23     (7.5) as follows:

24            **8-20.5-103. Petroleum storage tank fund - petroleum cleanup**  
25     **and redevelopment fund - creation - rules - repeal.** (7.5) ~~In addition~~  
26     ~~to the sources identified in subsection (1) of this section, the petroleum~~  
27     ~~storage tank fund includes the amount transferred from the petroleum~~

1 ~~cleanup and redevelopment fund in accordance with subsection (9)(c)(H)~~  
2 ~~of this section. On October 15, 2020, and the fifteenth day of each of the~~  
3 ~~next seven months, the state treasurer shall transfer five hundred thousand~~  
4 ~~dollars from the petroleum storage tank fund to the general fund. These~~  
5 ~~transfers are repayment for the transfer from the petroleum cleanup and~~  
6 ~~redevelopment fund, as the original amount transferred would have~~  
7 ~~otherwise transferred to the general fund.~~

8 **SECTION 4.** In Colorado Revised Statutes, 8-42-101, **amend**  
9 (3.6) as follows:

10 **8-42-101. Employer must furnish medical aid - approval of**  
11 **plan - fee schedule - contracting for treatment - no recovery from**  
12 **employee - medical treatment guidelines - accreditation of physicians**  
13 **and other medical providers - mental health provider qualifications**  
14 **- mileage reimbursement - rules - definition - repeal.** (3.6) (a) The  
15 two-tier accreditation system shall comprise the following programs:

16 (a) (I) A program establishing the accreditation requirements for  
17 physicians providing primary care to patients who have, as a result of  
18 their injury, been unable to return to work for more than three working  
19 days, referred to in this section as "time-loss injuries", which program  
20 shall be voluntary except in the case of chiropractors, for whom it shall  
21 be mandatory, and which shall be known as level I accreditation; and

22 (II) A program establishing the accreditation requirements for  
23 physicians providing impairment evaluation of injured workers, which  
24 program shall be known as level II accreditation.

25 (b) A physician who provides impairment evaluation of injured  
26 workers shall complete and must have received accreditation under the  
27 level II accreditation program. However, the authorized treating physician

1 providing primary care need not be level II accredited to determine that  
2 no permanent medical impairment has resulted from the injury.  
3 Specialists who do not render primary care to injured workers and who  
4 do not perform impairment evaluations do not require accreditation. The  
5 facility where a physician provides such services cannot be accredited.

6 (c) Both the level I and level II accreditation programs shall be  
7 implemented and available to physicians. All physicians who are required  
8 to be accredited shall complete the level II accreditation program or  
9 programs.

10 (d) The level I and level II accreditation programs shall operate in  
11 such a manner that the costs of the program are fully met by registration  
12 fees paid by the physicians. The registration fee for each program must  
13 cover the cost of all accreditation course work and materials.

14 (e) The accreditation system shall be established so as to provide  
15 physicians with an understanding of the administrative, legal, and medical  
16 roles and in such a manner that accreditation is accessible to every  
17 licensed physician, with consideration of specialty and geographic  
18 diversity.

19 (f) Initial accreditation shall be for a three-year period and may be  
20 renewed for successive three-year periods. The director by regulation may  
21 determine any additional training program required prior to accreditation  
22 renewal.

23 (g) The director shall, upon good cause shown, revoke the  
24 accreditation of any physician who violates the provisions of this  
25 subsection (3.6) or any rule promulgated by the director pursuant to this  
26 subsection (3.6), following a hearing on the merits before an  
27 administrative law judge, subject to review by the industrial claim appeals

1 office and the court of appeals, in accordance with all applicable  
2 provisions of article 43 of this title.

3 (h) If a physician whose accreditation has been revoked submits  
4 a claim for payment for services rendered subsequent to such revocation,  
5 the physician shall be considered in violation of section 10-1-128, ~~C.R.S.~~,  
6 and neither an insurance carrier nor a self-insured employer shall be under  
7 any obligation to pay such claim.

8 (i) A physician who provides treatment for nontime loss injuries  
9 need not be accredited to be reimbursed for the costs of such treatment  
10 pursuant to the provisions of the "Workers' Compensation Act of  
11 Colorado".

12 (j) (Deleted by amendment, L. 96, p. 151, § 2, effective July 1,  
13 1996.)

14 (k) The division shall make available to insurers, claimants, and  
15 employers a list of all accredited physicians and a list of all physicians  
16 whose accreditation has been revoked. Such lists shall be updated on a  
17 monthly basis.

18 (l) The registration fees collected pursuant to paragraph (d) of this  
19 subsection (3.6) shall be transmitted to the state treasurer, who shall credit  
20 the same to the physicians accreditation program cash fund, which is  
21 hereby created in the state treasury. Moneys in the physicians  
22 accreditation program cash fund are hereby continuously appropriated for  
23 the payment of the direct costs of providing the level I and level II  
24 accreditation courses and materials.

25 (m) All administrative costs associated with the level I and level  
26 II accreditation programs shall be paid out of the workers' compensation  
27 cash fund in accordance with appropriations made pursuant to section

1 8-44-112 (7).

2 (n) The director shall contract with the medical school of the  
3 university of Colorado for the services of a medical director to advise the  
4 director on issues of accreditation, impairment rating guidelines, medical  
5 treatment guidelines and utilization standards, and case management and  
6 to consult with the director on peer review activities as specified in this  
7 subsection (3.6) and section 8-43-501. The medical director shall be a  
8 medical doctor licensed to practice in this state with experience in  
9 occupational medicine. The director may contract with an appropriate  
10 private organization that meets the definition of a quality improvement  
11 organization as set forth in 42 U.S.C. sec. 1320c-1 to conduct peer review  
12 activities under this subsection (3.6) and section 8-43-501 and to  
13 recommend whether or not adverse action is warranted.

14 (o) Except as provided in this subsection (3.6), neither an  
15 insurance carrier nor a self-insured employer or injured worker shall be  
16 liable for costs incurred for an impairment evaluation rendered by a  
17 physician where there is a determination of permanent medical  
18 impairment if such physician is not level II accredited pursuant to the  
19 provisions of this subsection (3.6).

20 (p) (I) As used in this paragraph (p):

21 (A) "Case management" means a system developed by the  
22 insurance carrier in which the carrier shall assign a person knowledgeable  
23 in workers' compensation health care to communicate with the employer,  
24 employee, and treating physician to assure that appropriate and timely  
25 medical care is being provided.

26 (B) "Managed care" means the provision of medical services  
27 through a recognized organization authorized under the provisions of

1 parts 1, 3, and 4 of article 16 of title 10, ~~C.R.S.~~, or a network of medical  
2 providers accredited to practice workers' compensation under this  
3 subsection (3.6).

4 (II) Every employer or its insurance carrier shall offer at least  
5 managed care or medical case management in the counties of Denver,  
6 Adams, Jefferson, Arapahoe, Douglas, Boulder, Larimer, Weld, El Paso,  
7 Pueblo, and Mesa and shall offer medical case management in all other  
8 counties of the state.

9 (q) The division is authorized to accept moneys from any  
10 governmental unit as well as grants, gifts, and donations from individuals,  
11 private organizations, and foundations; except that no grant, gift, or  
12 donation may be accepted by the division if it is subject to conditions  
13 which are inconsistent with this article or any other laws of this state or  
14 which require expenditures from the workers' compensation cash fund  
15 which have not been approved by the general assembly. All moneys  
16 accepted by the division shall be transmitted to the state treasurer for  
17 credit to the workers' compensation cash fund.

18 (r) (I) This subsection (3.6) is repealed, effective September 1,  
19 2025.

20 (II) Prior to such repeal the accreditation process created by  
21 subsection (3.5) of this section and this subsection (3.6) shall be reviewed  
22 as provided for in section 24-34-104. ~~C.R.S.~~

23 **SECTION 5.** In Colorado Revised Statutes, **amend** 8-84-208 as  
24 follows:

25 **8-84-208. Business enterprise program cash fund - creation.**

26 There is hereby created in the state treasury the business enterprise  
27 program cash fund, referred to in this ~~article~~ SECTION as the "fund", which

1 consists of moneys accruing to the department from assessments against  
2 the net proceeds of each vending facility operator consistent with this part  
3 2, any income from vending machines on federal or state property that  
4 accrues to the department, and any federal moneys that may become  
5 available. Any moneys currently attributed to the business enterprise  
6 program and any reserves shall be transferred to this fund for future use  
7 consistent with this part 2. The moneys in the fund are subject to annual  
8 appropriation by the general assembly for the direct and indirect costs  
9 associated with the administration of this part 2. The state treasurer may  
10 invest any moneys in the fund not expended for the purposes of this part  
11 2 as provided in sections 24-36-109, 24-36-112, and 24-36-113. ~~C.R.S.~~  
12 All interest and income derived from the investment and deposit of  
13 moneys in the fund shall be credited to the fund. Any unexpended and  
14 unencumbered moneys remaining in the fund at the end of any fiscal year  
15 shall remain in the fund and shall not be credited or transferred to the  
16 general fund or any other fund.

17 **SECTION 6.** In Colorado Revised Statutes, 9-5.7-103, **amend**  
18 (5)(b) as follows:

19 **9-5.7-103. Restrooms - baby diaper changing stations -**  
20 **applicability - signage - enforcement.** (5) Subsections (1) and (2) of  
21 this section do not apply to the renovation of a restroom or a newly  
22 constructed building project if:

23 (b) The project has already progressed through the design review  
24 process, budgeting, and final approval by the governing body that has  
25 final approval over capital construction project expenditures as of August  
26 7, 2023; OR

27 **SECTION 7.** In Colorado Revised Statutes, 10-2-902, **amend** (5)

1 introductory portion and (6) as follows:

2 **10-2-902. Definitions.** As used in this part 9, unless the context  
3 otherwise requires:

4 (5) "Reinsurance intermediary-manager", ~~referred to in this part~~  
5 ~~9 as~~ OR "RM", means any person, firm, association, or corporation that  
6 has authority to bind or manages all or part of the assumed reinsurance  
7 business of a reinsurer (including the management of a separate division,  
8 department, or underwriting office) and acts as an agent for such reinsurer  
9 whether known as an RM, manager, or other similar term.  
10 Notwithstanding the provisions of this subsection (5), the following  
11 persons shall not be considered an RM, with respect to such reinsurer, for  
12 the purposes of this part 9:

13 (6) "Reinsurance intermediary-producer", ~~referred to in this part~~  
14 ~~9 as~~ OR "RP", means any person, other than an officer or employee of the  
15 ceding insurer, firm, association, or corporation, that solicits, negotiates,  
16 or places reinsurance cessions or retrocessions on behalf of a ceding  
17 insurer without the authority or power to bind reinsurance on behalf of  
18 such insurer.

19 **SECTION 8.** In Colorado Revised Statutes, 10-2-1002, **amend**  
20 (2)(a) introductory portion as follows:

21 **10-2-1002. Definitions.** As used in this part 10, unless the context  
22 otherwise requires:

23 (2) (a) "Managing general agent", ~~referred to in this part 10 as~~ OR  
24 "MGA", means any person, firm, association, or corporation who  
25 negotiates and binds ceding reinsurance contracts on behalf of an insurer  
26 or manages all or part of the insurance business of an insurer, including  
27 the management of a separate division, department, or underwriting

1 office, and acts as an agent for such insurer whether known as a  
2 managing general agent, manager, or other similar term, who, with or  
3 without the authority, either separately or together with affiliates,  
4 produces, directly or indirectly, and underwrites an amount of gross direct  
5 written premium equal to or more than five percent of the policyholder  
6 surplus as reported in the last annual statement of the insurer in any one  
7 quarter or year together with one or both of the following:

8 **SECTION 9.** In Colorado Revised Statutes, 10-4-1807, **amend**  
9 (4)(a) as follows:

10 **10-4-1807. Plan of operation - mandatory components -**  
11 **amendments - revocation by commissioner - rules.** (4) (a) If the  
12 commissioner determines that an approved plan of operation is  
13 insufficient to satisfy the requirements of this part 18, the commissioner  
14 shall provide at least thirty days' notice to the board of the commissioner's  
15 intent to revoke approval of all or part of the plan of operation. Within  
16 thirty days after the commissioner's notice of intent to revoke ALL OR  
17 PART OF the plan of operation, the board may submit a revised plan of  
18 operation or revised part of the plan of operation for the commissioner's  
19 review and approval.

20 **SECTION 10.** In Colorado Revised Statutes, 11-102-305, **amend**  
21 (1)(a)(IV) as follows:

22 **11-102-305. Records.** (1) (a) Information from the records of the  
23 division shall be revealed only to members of the banking board, except  
24 as follows:

25 (IV) Subject to subsection (1.5) of this section, the commissioner  
26 may exchange information obtained from money transmitters, state banks,  
27 and trust companies with the United States secretary of the treasury, the

1 secretary's designees, the United States attorney general, the attorney  
2 general's designee, or other state or United States territorial regulatory  
3 agencies pertaining to the condition of money transmitters or compliance  
4 with federal money laundering and other financial crimes laws, including,  
5 but not limited to, the federal "Bank Secrecy Act", 12 U.S.C. sec. 1951  
6 et seq., as amended; the federal "Right to Financial Privacy Act of 1978",  
7 12 U.S.C. sec. 3401 et seq., as amended; the federal "Money Laundering  
8 Control Act of 1986", ~~12~~ 18 U.S.C. secs. 1956 and 1957, as amended; and  
9 the federal "Annunzio-Wylie Anti-Money Laundering Act", 12 U.S.C.  
10 sec. 1811 et seq., as amended.

11 **SECTION 11.** In Colorado Revised Statutes, 11-102-306, **amend**  
12 (2)(c) as follows:

13 **11-102-306. Information confidential.** (2) The banking board,  
14 the commissioner, and their designees may exchange information with the  
15 United States comptroller of the currency, the federal deposit insurance  
16 corporation, the board of governors of the federal reserve system, the  
17 consumer financial protection bureau, the federal home loan bank in  
18 which an institution is a member or is making an application to become  
19 a member, the executive director of the department of regulatory  
20 agencies, the division of financial services, and banking or financial  
21 institution regulatory agencies of other states or United States territories,  
22 subject to any confidentiality agreement entered into between the banking  
23 board or the commissioner and the United States comptroller of the  
24 currency, the federal deposit insurance corporation, the board of  
25 governors of the federal reserve system, the consumer financial protection  
26 bureau, regulatory agencies of other states or United States territories, or  
27 the federal home loan bank in which an institution is a member or is

1 making an application to become a member. In addition, the banking  
2 board, the commissioner, and their designees may exchange information  
3 obtained by the banking board relating to:

4 (c) The activities of money transmitters, state banks, and trust  
5 companies pertaining to compliance with federal money laundering and  
6 other financial crimes laws, including the federal "Bank Secrecy Act", 12  
7 U.S.C. sec. 1951 et seq., as amended; the federal "Right to Financial  
8 Privacy Act of 1978", 12 U.S.C. sec. 3401 et seq., as amended; the federal  
9 "Money Laundering Control Act of 1986", ~~12~~ 18 U.S.C. secs. 1956 and  
10 1957, as amended; and the federal "Annunzio-Wylie Anti-Money  
11 Laundering Act", 12 U.S.C. sec. 1811 et seq., as amended, with the  
12 United States secretary of the treasury or the secretary's designees.

13 **SECTION 12.** In Colorado Revised Statutes, 12-135-114, **amend**  
14 (1)(a) and (2) introductory portion as follows:

15 **12-135-114. Insurance requirements.** (1) A funeral  
16 establishment shall obtain and maintain a professional liability insurance  
17 policy with liability limits of at least one million dollars. The funeral  
18 establishment must submit the certificate of professional liability  
19 insurance to the director:

20 (a) Within thirty days after the initial registration of the funeral  
21 establishment by the ~~board~~ DIRECTOR; and

22 (2) A funeral establishment shall notify the ~~board~~ DIRECTOR in  
23 writing within thirty days after doing any of the following for the  
24 professional liability insurance policy required by subsection (1) of this  
25 section:

26 **SECTION 13.** In Colorado Revised Statutes, 12-280-124, **amend**  
27 (4)(c)(II) as follows:

1           **12-280-124. Labeling - rules - definitions.** (4) (c) A pharmacy  
2 complies with subsection (4)(b) of this section if:

3           (II) The board affirms that the alternative method offered to a  
4 patient pursuant to ~~subsection (4)(c)(I)~~ SUBSECTION (4)(c)(I) of this  
5 section is substantially similar to the method of access the patient  
6 requested and meets the needs of the patient.

7           **SECTION 14.** In Colorado Revised Statutes, 14-10-116.5,  
8 **amend** (2)(f)(I)(B) as follows:

9           **14-10-116.5. Appointment in domestic relations cases - child**  
10 **and family investigator - disclosure - background check - definition.**

11           (2) (f) (I) The court shall not appoint a person from the eligibility registry  
12 to be a child and family investigator for a case pursuant to this section  
13 unless the court finds that the person is qualified as competent by training  
14 and experience in, at a minimum, domestic violence and its effects on  
15 children, adults, and families; coercive control; child abuse; and child  
16 sexual abuse in accordance with section 14-10-127.5. The person's  
17 training and experience must be provided by recognized sources with  
18 expertise in domestic violence, coercive control, and the traumatic effects  
19 of domestic violence in accordance with section 14-10-127.5. Initial and  
20 ongoing training must include, at a minimum:

21           (B) No less than fifteen hours of ongoing training every five  
22 years, required pursuant to section ~~14-10-127.5 (5)(a)(I)~~ 14-10-127.5  
23 (5)(a)(II).

24           **SECTION 15.** In Colorado Revised Statutes, 14-10-127, **amend**  
25 (4)(a.5)(I)(B) as follows:

26           **14-10-127. Evaluation and reports - training and**  
27 **qualifications of evaluators - disclosure - definitions.** (4) A person

1 shall not testify as an expert witness regarding a parental responsibilities  
2 or parenting time evaluation that the person has performed pursuant to  
3 this section unless the court finds that the person is qualified as  
4 competent, by training and experience, in the areas of:

5 (a.5) (I) The effects of domestic violence on children, adults, and  
6 families, including the connection between domestic violence and trauma  
7 on children, coercive control, child abuse, and child sexual abuse in  
8 accordance with section 14-10-127.5. The person's training and  
9 experience must be provided by recognized sources with expertise in  
10 domestic violence and the traumatic effects of domestic violence and  
11 coercive control in accordance with section 14-10-127.5. Initial and  
12 ongoing training must include, at a minimum:

13 (B) No less than fifteen hours of ongoing training every five  
14 years, required pursuant to section ~~14-10-127.5 (5)(a)(I)~~ 14-10-127.5  
15 (5)(a)(II).

16 **SECTION 16.** In Colorado Revised Statutes, 16-8.6-108, **amend**  
17 (3) as follows:

18 **16-8.6-108. Eligibility - initial intake - acceptance - release**  
19 **from custody.** (3) Prior to referring a defendant to the bridges  
20 wraparound care program, when the defendant is charged with an offense  
21 described in section 24-4.1-302 (1), the district attorney shall comply with  
22 all relevant provisions of ~~section 24-4.1-300.1, et seq~~ PART 3 OF ARTICLE  
23 4.1 OF TITLE 24.

24 **SECTION 17.** In Colorado Revised Statutes, 18-12-101, **amend**  
25 (1) as follows:

26 **18-12-101. Peace officer affirmative defense - definitions.**  
27 (1) As used in this article 12, unless the context otherwise requires:

1 (a) "Adult" means any person eighteen years of age or older.

15 traffic has an environmental impact;

16 (B) The United States environmental protection agency has  
17 classified the Denver metro/north front range area as being in severe  
18 nonattainment for ozone and ground level ozone, which has serious  
19 impacts on human health, particularly for vulnerable populations;

20 (C) According to the greenhouse gas pollution reduction roadmap,  
21 published by the Colorado energy office and dated January 14, 2021, the  
22 transportation sector is the single largest source of greenhouse gas  
23 pollution in Colorado;

24 (D) Nearly sixty percent of the greenhouse gas emissions from the  
25 transportation sector come from light-duty vehicles, which constitute the  
26 majority of cars and trucks that Coloradans drive every day;

27 (E) As part of the greenhouse gas pollution reduction roadmap, a

1 strategic action plan to achieve legislatively adopted targets of reducing  
2 greenhouse gas pollution economy-wide by fifty percent below 2005  
3 levels by 2030 and ninety percent by 2050, the state committed to  
4 reducing emissions from the transportation sector by forty-one percent by  
5 2030 from a 2005 baseline; and

6 (F) The greenhouse gas transportation planning standard adopted  
7 by the transportation commission in 2021 set a target to reduce  
8 transportation greenhouse gas emissions through the transportation  
9 planning process by one million five hundred thousand tons by 2030;

10 (b) The general assembly further finds and declares that:

11 (I) The environmental and economic issues that result from

20 **SECTION 74. Act subject to petition - effective date.** This act  
21 takes effect at 12:01 a.m. on the day following the expiration of the  
22 ninety-day period after final adjournment of the general assembly; except  
23 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
24 of the state constitution against this act or an item, section, or part of this  
25 act within such period, then the act, item, section, or part will not take  
26 effect unless approved by the people at the general election to be held in

- 1 November 2026 and, in such case, will take effect on the date of the
- 2 official declaration of the vote thereon by the governor.
