

SENATE COMMITTEE AMENDMENTS

2022 Regular Session

Amendments proposed by Senate Committee on Judiciary C to Reengrossed House Bill No. 8 by Representative Fontenot

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" change "R.S. 14:95(H)(1)" to "R.S. 14:95(H)(1) and (K)"

3 AMENDMENT NO. 2

4 On page 1, line 6, after "Section 1." change "R.S. 14:95(H)(1) is" to "R.S. 14:95(H)(1) and
5 (K) are"

6 AMENDMENT NO. 3

7 On page 2, line 1, delete "retired members of the United States Congress,"

8 AMENDMENT NO. 4

9 On page 2, after line 5, insert the following:

10 "K.(1) The provisions of this Section shall not prohibit a retired justice or
11 judge of the supreme court, courts of appeal, district courts, parish courts, juvenile
12 courts, family courts, city courts, retired attorney general, retired assistant attorneys
13 general, retired district attorneys, retired assistant district attorneys, retired members
14 of the United States Congress, and former members of either house of the legislature
15 from possessing and concealing a handgun on their person provided that such retired
16 person or former member of the legislature is qualified annually, at their expense, in
17 the use of firearms by the Council on Peace Officer Standards and Training and has
18 on their person valid identification showing proof of their status as a former member
19 of the legislature or as a retired justice, judge, attorney general, assistant attorney
20 general, district attorney, or assistant district attorney. For a former member of the
21 legislature, the valid identification showing proof of status as a former legislator
22 required by the provisions of this Paragraph shall be a legislative badge issued by the
23 Louisiana Legislature that shall include the former member's name, the number of
24 the district that the former member was elected to represent, the years that the former
25 member served in the legislature, and words that indicate the person's status as a
26 former member of the legislature.

27 (2) The retired justice, judge, attorney general, assistant attorney general,
28 district attorney, ~~or~~ assistant district attorney, or former member of the United States
29 Congress or either house of the legislature shall be qualified annually in the use of
30 firearms by the Council on Peace Officer Standards and Training and have proof of
31 qualification. However, this Subsection shall not apply to a retired justice, judge,
32 attorney general, assistant attorney general, district attorney, or assistant district
33 attorney or to a former member of the legislature or the United States Congress who
34 is medically retired based upon any mental impairment, or who has entered a plea
35 of guilty or nolo contendere to or been found guilty of a felony offense. For the
36 purposes of this Subsection, "retired district attorney" or "retired assistant district
37 attorney" shall mean a district attorney or an assistant district attorney receiving
38 retirement benefits from the District Attorneys' Retirement System.
