31 carry permit issued pursuant to sections 571.101 to 571.121, or a concealed carry endorsement

33 concealed carry permit or the concealed carry endorsement, the court shall issue an appropriate
34 order to cause the revocation of the concealed carry permit and, if applicable, the concealed carry
35 endorsement. Costs shall not be assessed against the sheriff.

36 3. The finder of fact, in any action brought against a permit or endorsement holder pursuant
37 to subsection 1 of this section, shall make findings of fact and the court shall make conclusions of
38 law addressing the issues at dispute. If it is determined that the plaintiff in such an action acted
39 without justification or with malice or primarily with an intent to harass the permit or endorsement
40 holder or that there was no reasonable basis to bring the action, the court shall order the plaintiff to
41 pay the defendant/respondent all reasonable costs incurred in defending the action including, but not
42 limited to, attorney's fees, deposition costs, and lost wages. Once the court determines that the
43 plaintiff is liable to the defendant/respondent for costs and fees, the extent and type of fees and costs
44 to be awarded should be liberally calculated in defendant/respondent's favor. Notwithstanding any
45 other provision of law, reasonable attorney's fees shall be presumed to be at least one hundred fifty
46 dollars per hour.

47 4. Any person aggrieved by any final judgment rendered by a small claims court in a

5 571.121, or a certificate of qualification for a concealed carry endorsement issued prior to August
6 28, 2013, so long as the sheriff acted in good faith."; and

14 extended concealed carry permit shall authorize any person to carry concealed firearms into:

15 (1) Any police, sheriff, or highway patrol office or station without the consent of the chief
16 law enforcement officer in charge of that office or station. Possession of a firearm in a vehicle on
17 the premises of the office or station shall not be a criminal offense so long as the firearm is not
18 removed from the vehicle or brandished while the vehicle is on the premises;

19 (2) Within twenty-five feet of any polling place on any election day. Possession of a firearm
20 in a vehicle on the premises of the polling place shall not be a criminal offense so long as the
21 firearm is not removed from the vehicle or brandished while the vehicle is on the premises;

22 (3) The facility of any adult or juvenile detention or correctional institution, prison or jail.
23 Possession of a firearm in a vehicle on the premises of any adult, juvenile detention, or correctional
24 institution, prison or jail shall not be a criminal offense so long as the firearm is not removed from
25 the vehicle or brandished while the vehicle is on the premises;

26 (4) Any courthouse solely occupied by the circuit, appellate or supreme court, or any
27 courtrooms, administrative offices, libraries, or other rooms of any such court whether or not such
28 court solely occupies the building in question. This subdivision shall also include, but not be
29 limited to, any juvenile, family, drug, or other court offices, any room or office wherein any of the
30 courts or offices listed in this subdivision are temporarily conducting any business within the

7 teacher or administrator of an elementary or secondary school who has been designated by his or her
8 school district as a school protection officer and is carrying a firearm in a school within that district,
9 in which case no consent is required. Possession of a firearm in a vehicle on the premises of any
10 higher education institution or elementary or secondary school facility shall not be a criminal
11 offense so long as the firearm is not removed from the vehicle or brandished while the vehicle is on
12 the premises;

13 (11) Any portion of a building used as a child care facility without the consent of the
14 manager. Nothing in this subdivision shall prevent the operator of a child care facility in a family
15 home from owning or possessing a firearm or a Missouri lifetime or extended concealed carry
16 permit;

17 (12) Any riverboat gambling operation accessible by the public without the consent of the
18 owner or manager under rules promulgated by the gaming commission. Possession of a firearm in a
19 vehicle on the premises of a riverboat gambling operation shall not be a criminal offense so long as
20 the firearm is not removed from the vehicle or brandished while the vehicle is on the premises;

21 (13) Any gated area of an amusement park. Possession of a firearm in a vehicle on the
22 premises of the amusement park shall not be a criminal offense so long as the firearm is not
23 removed from the vehicle or brandished while the vehicle is on the premises;

4 4. Any person aggrieved by any final judgment rendered by a small claims court in a
5 petition for revocation of a Missouri lifetime or extended concealed carry permit may have a right to
6 trial de novo as provided in sections 512.180 to 512.320.

7 5. The office of the county sheriff or any employee or agent of the county sheriff shall not
8 be liable for damages in any civil action arising from alleged wrongful or improper granting,
9 renewing, or failure to revoke a Missouri lifetime or extended concealed carry permit issued under
10 sections 571.205 to 571.230 so long as the sheriff acted in good faith."; and
