16	clearly shows that	t the device was manufactured or imported after the effective date of this Article.
17	(d) Punis	hment. – A violation of this section is punishable as a Class E felony."
18	SECT	FION 2. This act becomes effective December 1, 2025, and applies to offenses
19	committed on or	after that date.
