9 An Act relating to application for firearms; amending
10 21 O.S. 2011, Section 1290.18, as amended by Section
11 37, Chapter 259, O.S.L. 2012 (21 O.S. Supp. 2014,
12 Section 1290.18), which relates to certain
13 application contents; deleting certain requirement;
14 and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 21 O.S. 2011, Section 1290.18, as
17 amended by Section 37, Chapter 259, O.S.L. 2012 (21 O.S. Supp. 2014,
18 Section 1290.18), is amended to read as follows:

19 Section 1290.18.

20 APPLICATION FORM CONTENTS

21 The application shall be completed upon the sworn oath of the
22 applicant as provided in paragraph 5 of Section 1290.12 of this
23 title. The application form shall be provided by the Oklahoma State
24 Bureau of Investigation and shall contain the following information
in addition to any other information deemed relevant by the Bureau:

- 1 1. Applicant's full legal name;
- 2 2. Applicant's birth name, alias names or nicknames;
- 3 3. Maiden name, if applicable;
- 4 4. County of residence;
- 5 5. Length of residency at the current address;
- 6 6. Previous addresses for the preceding three (3) years;
- 7 7. Place of birth;
- 8 8. Date of birth;
- 9 9. Declaration of citizenship and date United States
- 10 citizenship was acquired, if applicable;
- 11 10. Race;
- 12 11. Weight;
- 13 12. Height;
- 14 13. Sex;
- 15 14. Color of eyes;
- 16 15. ~~Social Security number;~~
- 17 ~~16.~~ Current driver license number;
- 18 ~~17.~~ 16. Military service number, if applicable;
- 19 ~~18.~~ 17. Law enforcement identification numbers, if applicable;
- 20 ~~19.~~ 18. Current occupation;
- 21 ~~20.~~ 19. Authorized type or types of pistol for which the
- 22 applicant qualified as stated on the certificate of training or
- 23 exemption of training which shall be stated as either derringer,
- 24 revolver, semiautomatic pistol, or some combination of derringer,

1 revolver and semiautomatic pistol and the maximum ammunition
2 capacity of the firearm shall be .45 caliber;

3 ~~21.~~ 20. An acknowledgment that the applicant desires a handgun
4 license as a means of lawful self-defense and self-protection and
5 for no other intent or purpose;

6 ~~22.~~ 21. A statement that the applicant has never been convicted
7 of any felony offense in this state, another state or pursuant to
8 any federal offense;

9 ~~23.~~ 22. A statement that the applicant has none of the
10 conditions which would preclude the issuing of a handgun license
11 pursuant to any of the provisions of Sections 1290.10 and 1290.11 of
12 this title and that the applicant further meets all of the
13 eligibility criteria required by Section 1290.9 of this title;

14 ~~24.~~ 23. An authorization for the Oklahoma State Bureau of
15 Investigation to investigate the applicant and any or all records
16 relating to the applicant for purposes of approving or denying a
17 handgun license pursuant to the provisions of the Oklahoma Self-
18 Defense Act;

19 ~~25.~~ 24. An acknowledgment that the applicant has been furnished
20 a copy of the Oklahoma Self-Defense Act and is knowledgeable about
21 its provisions;

22 ~~26.~~ 25. A statement that the applicant is the identical person
23 who completed the firearms training course for which the original
24 training certificate is submitted as part of the application or a

1 statement that the applicant is the identical person who is exempt
2 from firearms training for which the original exemption certificate
3 is submitted as part of the application, whichever is applicable to
4 the applicant;

5 ~~27.~~ 26. A conspicuous warning that the application is executed
6 upon the sworn oath of the applicant and that any false or
7 misleading answer to any question or the submission of any false
8 information or documentation by the applicant is punishable by
9 criminal penalty as provided in paragraph 5 of Section 1290.12 of
10 this title;

11 ~~28.~~ 27. A signed verification that the contents of the
12 application are known to the applicant and are true and correct;

13 ~~29.~~ 28. Two separate places for the original signature of the
14 applicant;

15 ~~30.~~ 29. A place for attachment of a passport size photograph of
16 the applicant; and

17 ~~31.~~ 30. A place for the signature and verification of the
18 identity of the applicant by the sheriff or the sheriff's designee.

19 Information provided by the person on an application for a
20 handgun license shall be confidential except to law enforcement
21 officers or law enforcement agencies.

22 SECTION 2. This act shall become effective November 1, 2015.
