11 An Act relating to relating to the State Department  
12 of Health; providing that employees of Department be  
13 in classified service and subject to Merit System of  
14 Personnel Administration; providing exceptions;  
15 amending 74 O.S. 2011, Section 840-5.5, as last  
16 amended by Section 6, Chapter 117, O.S.L. 2014 (74  
17 O.S. Supp. 2014, Section 840-5.5) which relates to  
18 unclassified employees; providing for codification;  
19 providing an effective date; and declaring an  
20 emergency.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 840-5.25 of Title 74, unless  
24 there is created a duplication in numbering, reads as follows:

A. The State Department of Health shall be under the Merit  
System. Except as otherwise provided in subsection B of this  
section or Section 840-5.5 of Title 74 of the Oklahoma Statutes or

1 except as otherwise provided by law, all offices, positions, and  
2 personnel shall be classified and subject to the provisions of the  
3 Merit System of Personnel Administration and rules promulgated  
4 pursuant thereto. This section shall supersede and repeal any and  
5 all executive orders issued pursuant to the Oklahoma Personnel Act  
6 to place the agency or its predecessors under the Merit System.

7 B. In addition to offices, positions, and personnel that are  
8 unclassified as specifically provided by law, the State Department  
9 of Health may place in the unclassified service any employee who is  
10 initially employed on or after July 1, 2015, in the following  
11 positions:

- 12 1. State Commissioner of Health;
- 13 2. Assistant State Commissioner of Health;
- 14 3. Senior Deputy Commissioner of Health;
- 15 4. Deputy Commissioner of Health;
- 16 5. Assistant Deputy Commissioner of Health;
- 17 6. Chief Operating Officer;
- 18 7. Service Director;
- 19 8. County Health Department Regional Director;
- 20 9. Assistant Service Director;
- 21 10. Administrative Program Manager;
- 22 11. Executive Assistant;
- 23 12. Executive Secretary;
- 24 13. Paralegal;

- 1 14. Legal Assistant;
- 2 15. Legal Secretary;
- 3 16. Commissioned Peace Officer;
- 4 17. Internal Auditor;
- 5 18. Business Officer;
- 6 19. Operations Manager;
- 7 20. State Epidemiologist; and
- 8 21. All positions or employees assigned to the Behavioral Risk
- 9 Surveillance System for Health Care Information.

10 SECTION 2. AMENDATORY 74 O.S. 2011, Section 840-5.5, as  
11 last amended by Section 6, Chapter 117, O.S.L. 2014 (74 O.S. Supp.  
12 2014, Section 840-5.5), is amended to read as follows:

13 Section 840-5.5. A. The following offices, positions, and  
14 personnel shall be in the unclassified service and shall not be  
15 placed under the classified service:

16 1. Persons chosen by popular vote or appointment to fill an  
17 elective office, and their employees, except the employees of the  
18 Corporation Commission, the State Department of Education and the  
19 Department of Labor;

20 2. Members of boards and commissions, and heads of agencies;  
21 also one principal assistant or deputy and one executive secretary  
22 for each state agency;

23 3. All judges, elected or appointed, and their employees;

24

1 4. Persons employed with one-time, limited duration, federal or  
2 other grant funding that is not continuing or indefinitely  
3 renewable. The length of the unclassified employment shall not  
4 exceed the period of time for which that specific federal funding is  
5 provided;

6 5. All officers and employees of The Oklahoma State System of  
7 Higher Education, State Board of Education and Oklahoma Department  
8 of Career and Technology Education;

9 6. Persons employed in a professional or scientific capacity to  
10 make or conduct a temporary and special inquiry, investigation, or  
11 examination on behalf of the Legislature or a committee thereof or  
12 by authority of the Governor. These appointments and authorizations  
13 shall terminate on the first day of the regular legislative session  
14 immediately following the appointment, if not terminated earlier.  
15 However, nothing in this paragraph shall prevent the reauthorization  
16 and reappointment of any such person. Any such appointment shall be  
17 funded from the budget of the appointing authority;

18 7. Election officials and employees;

19 8. Temporary employees employed to work less than one thousand  
20 (1,000) hours in any twelve-month period, and seasonal employees  
21 employed by the Oklahoma Tourism and Recreation Department pursuant  
22 to Section 2241 of this title who work less than one thousand six  
23 hundred (1,600) hours in any twelve-month period;

1           9. Department of Public Safety employees occupying the  
2 following offices or positions:

- 3           a. administrative aides to the Commissioner,
- 4           b. executive secretaries to the Commissioner,
- 5           c. the Governor's representative of the Oklahoma Highway  
6           Safety Office who shall be appointed by the Governor,
- 7           d. Highway Patrol Colonel,
- 8           e. Highway Patrol Lieutenant Colonel,
- 9           f. Director of Finance,
- 10          g. noncommissioned pilots,
- 11          h. Information Systems Administrator,
- 12          i. Law Enforcement Telecommunications System Specialist,
- 13          j. Director of Driver Compliance,
- 14          k. Director of Transportation Division,
- 15          l. Director of the Oklahoma Highway Safety Office,
- 16          m. Civil Rights Administrator,
- 17          n. Budget Analyst,
- 18          o. Comptroller,
- 19          p. Chaplain,
- 20          q. Helicopter Mechanic,
- 21          r. Director of Safety Compliance,
- 22          s. Human Resources Director,
- 23          t. Administrator of Department Services, and

1 u. a maximum of seven (7) positions for the purpose of  
2 administering programs in the Oklahoma Highway Safety  
3 Office, within full-time employee limitations of the  
4 Department, employed with federal funding that is  
5 continuing or indefinitely renewable. The  
6 authorization for such positions shall be terminated  
7 if the federal funding for positions is discontinued;  
8 provided, any person appointed to a position prescribed in  
9 subparagraph d or e of this paragraph shall have a right of return  
10 to the classified commissioned position without any loss of rights,  
11 privileges or benefits immediately upon completion of the duties in  
12 the unclassified commissioned position;

13 10. Professional trainees only during the prescribed length of  
14 their course of training or extension study;

15 11. Students who are employed on a part-time basis, which shall  
16 be seventy-five percent (75%) of a normal forty-hour work week or  
17 thirty (30) hours per week, or less, or on a full-time basis if the  
18 employment is pursuant to a cooperative education program such as  
19 that provided for under Title I IV-D of the Higher Education Act of  
20 1965 (20 U.S.C. 1087a-1087c), as amended, and who are regularly  
21 enrolled in:

22 a. an institution of higher learning within The Oklahoma  
23 State System of Higher Education,  
24

- 1           b.    an institution of higher learning qualified to become  
2                    coordinated with The Oklahoma State System of Higher  
3                    Education. For purposes of this section, a student  
4                    shall be considered a regularly enrolled student if  
5                    the student is enrolled in a minimum of five (5) hours  
6                    of accredited graduate courses or a minimum of ten  
7                    (10) hours of accredited undergraduate courses,  
8                    provided, however, the student shall only be required  
9                    to be enrolled in a minimum of six (6) hours of  
10                   accredited undergraduate courses during the summer, or  
11           c.    high school students regularly enrolled in a high  
12                   school in Oklahoma and regularly attending classes  
13                   during such time of enrollment;

14           12. The spouses of personnel who are employed on a part-time  
15 basis to assist or work as a relief for their spouses in the  
16 Oklahoma Tourism and Recreation Department;

17           13. Service substitute attendants who are needed to replace  
18 museum and site attendants who are unavoidably absent. Service  
19 substitutes may work as part-time or full-time relief for absentees  
20 for a period of not more than four (4) weeks per year in the  
21 Oklahoma Historical Society sites and museums; such substitutes will  
22 not count towards the agency's full-time-equivalent (FTE) employee  
23 limit;

1 14. Employees of the Oklahoma House of Representatives, the  
2 State Senate, or the Legislative Service Bureau;

3 15. Corporation Commission personnel occupying the following  
4 offices and positions:

- 5 a. Administrative aides, and executive secretaries to the  
6 Commissioners,
- 7 b. Directors of all the divisions, personnel managers and

2 position to serve as an acting incumbent. All unclassified  
3 appointments created pursuant to this paragraph shall expire no  
4 later than two (2) years from the date of appointment. Classified  
5 employees accepting unclassified appointments and compensation  
6 pursuant to this paragraph shall be entitled to participate without  
7 interruption in any benefit programs available to classified  
8 employees, including retirement and insurance programs. Immediately  
9 upon termination of an unclassified appointment pursuant to this  
10 paragraph, an employee on assignment from the classified service  
11 shall have a right to be restored to the classified service and  
12 reinstated to the former job family level and compensation plus any  
13 adjustments and increases in salary or benefits which the employee  
14 would have received but for the leave of absence;

22       C. Effective July 1, 1996, authorization for unclassified

24 resolution shall terminate June 30 of the ensuing fiscal year after

1 the authorization unless the authorization is codified in the  
2 Oklahoma Statutes or the termination is otherwise provided in the  
3 legislation.

4 D. The appointing authority of agencies participating in the  
5 statewide information systems project may establish unclassified  
6 positions and appoint unclassified employees to the project as  
7 needed. Additional unclassified positions may be established, if  
8 required, to appoint an unclassified employee to perform the duties  
9 of a permanent classified employee who is temporarily absent from a  
10 classified position as a result of assignment to this project. All  
11 unclassified appointments under this authority shall expire no later  
12 than December 31, 2007, and all unclassified positions established  
13 to support the project shall be abolished. Both the positions and  
14 appointments resulting from this authority shall be exempt from any

17 may request a leave of absence from classified status and accept an

10 be in full force from and after its passage and approval.
