

HOUSE AMENDMENTS TO HOUSE BILL 2278

By COMMITTEE ON TRANSPORTATION AND ECONOMIC DEVELOPMENT

1 On page 1 of the printed bill, line 15, after “agency” insert “or organization”.

2 Delete lines 28 through 30.

3 On page 2, delete lines 1 and 2 and insert:

4 “(b) Authorization for the issuance of lottery bonds will increase the likelihood of federal fund-
5 ing for maintenance of the project, encourage the development of public and private sector part-
6 nerships to continue the modernization and expansion of the Oregon International Port of Coos Bay,
7 including the development and construction of modern multipurpose, multimodal terminal facilities
8 for the Coos Bay harbor, and add new income that will directly benefit Oregon’s dredging, con-
9 struction or maritime industries.”.

10 Delete lines 31 through 40 and insert:

11 “(b) In the biennium beginning July 1, 2015, up to \$10 million in net proceeds of lottery bonds
12 to the Coos Bay Channel Fund established in section 15, chapter 746, Oregon Laws 2007, for dis-
13 tribution to the primary sponsor after the director finds that the primary sponsor has taken action
14 pursuant to the grant agreement required in section 14, chapter 746, Oregon Laws 2007, that trig-
15 gers the distribution of bond proceeds described in this paragraph.

16 “(c) In the biennium beginning July 1, 2017, up to \$5 million in net proceeds of lottery bonds to
17 the Coos Bay Channel Fund established in section 15, chapter 746, Oregon Laws 2007, for distrib-
18 ution to the primary sponsor after the director finds that the primary sponsor has taken action
19 pursuant to the grant agreement required in section 14, chapter 746, Oregon Laws 2007, that trig-
20 gers the distribution of bond proceeds described in this paragraph.

21 “(d) In the biennium beginning July 1, 2019, up to \$40 million in net proceeds of lottery bonds
22 to the Coos Bay Channel Fund established in section 15, chapter 746, Oregon Laws 2007, for dis-
23 tribution to the primary sponsor after the director finds that the primary sponsor has taken action
24 pursuant to the grant agreement required in section 14, chapter 746, Oregon Laws 2007, that trig-
25 gers the distribution of bond proceeds described in this paragraph.”.

26 On page 3, delete lines 28 through 45.

27 On page 4, delete lines 1 through 9 and insert:

28 “(3)(a) Prior to the distribution of the bond proceeds described in section 13 (2)(b), chapter 746,
29 Oregon Laws 2007, the primary sponsor shall provide to the director a budget document outlining
30 expenditures for the Coos Bay Channel Project and shall verify and certify to the director that the
31 primary sponsor has prepared and submitted to the United States Army Corps of Engineers the
32 tentatively selected plan report identifying the preferred alternative for the project.

33 “(b) Prior to the distribution of the bond proceeds described in section 13 (2)(c), chapter 746,
34 Oregon Laws 2007, the primary sponsor shall provide to the director a budget document outlining
35 expenditures for the Coos Bay Channel Project and verify and certify to the director that:

1 “(A) The final environmental impact statement and the draft record of decision have been issued
2 in accordance with the National Environmental Policy Act (42 U.S.C. 4321 et seq.); and

3 “(B) The Oregon International Port of Coos Bay has prepared and submitted to the United
4 States Army Corps of Engineers a draft combined report pursuant to section 204 of the Water Re-
5 sources Development Act of 1986 (P.L. 99-662) and section 14 of the Rivers and Harbors Appropri-
6 ation Act of 1899 (33 U.S.C. 408) for technical agency review.

7 “(c) Prior to the distribution of the bond proceeds described in section 13 (2)(d), chapter 746,
8 Oregon Laws 2007, the primary sponsor shall provide to the director a budget document outlining
9 expenditures for the Coos Bay Channel Project and verify and certify to the director that:

10 “(A) The Director of Civil Works for the United States Army Corps of Engineers has approved
11 the project pursuant to section 14 of the Rivers and Harbors Appropriation Act of 1899;

12 “(B) The United States Army Corps of Engineers Portland District has issued permits for con-
13 struction pursuant to section 404 of the Federal Water Pollution Control Act (P.L. 92-500), as
14 amended, and section 10 of the Rivers and Harbors Appropriation Act of 1899; and

15 “(C) The Assistant Secretary of the Army (Civil Works) for the United States Army Corps of
16 Engineers has approved and executed an agreement pursuant to section 204(f) of the Water Re-
17 sources Development Act of 1986.”
