

## HOUSE AMENDMENTS TO HOUSE BILL 3535

By COMMITTEE ON HUMAN SERVICES AND HOUSING

1 On page 1 of the printed bill, line 2, after “ORS” delete the rest of the line and line 3 and insert  
2 “411.075, 411.175, 411.635, 411.892, 412.001, 412.006, 412.009, 412.024, 412.029, 412.039, 412.049,  
3 412.054, 412.064, 412.079, 412.089, 412.124, 412.161, 412.991 and 414.025 and sections 1, 7 and 8,  
4 chapter 604, Oregon Laws 2011; repealing ORS 411.077, 411.078, 412.076, 412.099, 412.104 and 412.114  
5 and section 26, chapter 722, Oregon Laws 2013; and declaring an emergency.”.

6 Delete lines 23 through 30 and pages 2 through 5 and insert:

7 **“SECTION 1. (1) The Legislative Assembly finds that:**

8 **“(a) The temporary assistance for needy families program is the state’s primary safety**  
9 **net for families with children who live in extreme poverty; and**

10 **“(b) Outcomes for disadvantaged youth improve when youth have a connection to youth**  
11 **employment and training programs.**

12 **“(2) In order to provide a path out of poverty for families, adults and youth and to max-**  
13 **imize the services available to assist families, adults and youth in moving out of poverty, the**  
14 **Department of Human Services and any other state agency that serves low-income families,**  
15 **adults or youth shall work with other agencies and organizations, by contract or by inter-**  
16 **governmental or cooperative agreement, to provide:**

17 **“(a) Cash aid to families;**

18 **“(b) Strength-based case management;**

19 **“(c) Work and work preparation services;**

20 **“(d) Family stability resources and support; and**

21 **“(e) Youth employment and training programs.**

22 **“SECTION 2. The Department of Human Services may provide support service payments**  
23 **for transportation, housing or other costs as necessary to prevent the loss of employment**  
24 **that will result in the family qualifying for temporary assistance for needy families program**  
25 **aid under ORS 412.006.**

26 **“SECTION 3. (1) Notwithstanding ORS 411.877 to 411.896, beginning on July 1, 2016, the**  
27 **Department of Human Services, in coordination with workforce agencies and stakeholders,**  
28 **may operate a 12-month program to pilot alternative ways to operate the JOBS Plus program**  
29 **established in ORS 411.878 for the purpose of increasing employment outcomes of partic-**  
30 **ipants in the JOBS Plus program, including youth.**

31 **“(2) The department shall include in its annual report under ORS 411.896 the status of a**  
32 **program described in subsection (1) of this section and the department’s findings and rec-**  
33 **ommendations based on the program.**

34 **“SECTION 4. (1) The need for and amount of aid pursuant to the temporary assistance**  
35 **for needy families to be granted for any dependent child or relative pursuant to ORS 412.006**

1 shall be determined, in accordance with the rules of the Department of Human Services,  
2 taking into account:

3 “(a) The income, resources and maintenance available to such child and relative from  
4 whatever source derived, allowable deductions and the statewide income and payment stan-  
5 dards.

6 “(b) The income and financial condition of the stepparent, if any, of the child for whom  
7 aid is sought.

8 “(2) Subsection (1)(b) of this section is not intended to relieve any parent of any legal  
9 obligation with respect to the support of the natural or adopted children of the parent.

10 “(3) In determining the need for and amount of aid to be granted under subsection (1)  
11 of this section and under ORS 411.070, the department shall:

12 “(a) Disregard no less than \$50 of the amount of child support received for each child per  
13 month, up to a total of \$200 or the maximum established by federal law, for the family; and

14 “(b) Disregard any other amounts of income and resources of the family as the depart-  
15 ment may prescribe by rule.

16 “SECTION 5. Notwithstanding any other provision of law, ORS 418.647 shall not be con-  
17 sidered to have been added to or made a part of ORS 412.001 to 412.069 for the purpose of  
18 statutory compilation or for the application of definitions, penalties or administrative pro-  
19 visions applicable to statute sections in that series.

20 “SECTION 6. ORS 412.124 is amended to read:

21 “412.124. *[(1) The Department of Human Services shall continue to provide aid to families residing*  
22 *in Oregon that become ineligible for temporary assistance for needy families under ORS 412.006 due*  
23 *to employment or increased hours of work.]*

24 “*[(2) Families may receive aid under this section for 12 consecutive months or until the household*  
25 *income exceeds 250 percent of the federal poverty guidelines, whichever occurs first, as long as the*  
26 *caretaker relatives participate in combined employment and work activities for the number of hours*  
27 *required each month to satisfy federally required participation rates.]*

28 “*[(3) If the needy caretaker relatives cease to participate in employment or suitable activities for a*  
29 *sufficient number of hours each month to satisfy federally required participation rates, the department*  
30 *shall determine eligibility under ORS 412.006 based upon information available to the department. If*  
31 *the department does not have sufficient information available to determine eligibility for aid under ORS*  
32 *412.006, the department shall provide notice and an opportunity for hearing prior to terminating aid.*  
33 *The notice must state the information that the department lacks and that the caretaker relatives must*  
34 *provide to complete the determination for aid.]*

35 “*[(4) The department by rule shall establish standards for aid provided under this section. The*  
36 *department must disregard such aid for purposes of publicly subsidized child care assistance.]*

37 “*[(5) In addition to money payments, aid includes necessary support service payments and services*  
38 *as part of the job opportunity and basic skills program to directly or indirectly assist the family in*  
39 *achieving long term financial stability.]*

40 “(1) The Department of Human Services shall provide aid for up to three consecutive  
41 months to a family if:

42 “(a) The family is residing in this state;

43 “(b) The family becomes ineligible for aid under the temporary assistance for needy  
44 families program due to employment or increased hours of work; and

45 “(c) The caretaker relative is employed.

1       **“(2) The department shall adopt by rule standards for the aid provided under this section.**

2       **“SECTION 6a.** ORS 412.124, as amended by section 6 of this 2015 Act, is amended to read:

3       “412.124. [(1) *The Department of Human Services shall provide aid for up to three consecutive*

4       *months to a family if:]*

5       “[(a) *The family is residing in this state;*]

6       “[(b) *The family becomes ineligible for aid under the temporary assistance for needy families pro-*

7       *gram due to employment or increased hours of work; and]*

8       “[(c) *The caretaker relative is employed.*]

9       “[(2) *The department shall adopt by rule standards for the aid provided under this section.*]

10       **“(1) The Department of Human Services shall continue to provide aid to families residing**

11       **in Oregon that become ineligible for temporary assistance for needy families under ORS**

12       **412.006 due to employment or increased hours of work.**

13       **“(2) Families may receive aid under this section for 12 consecutive months or until the**

14       **household income exceeds 250 percent of the federal poverty guidelines, whichever occurs**

15       **first, as long as the caretaker relatives participate in combined employment and work ac-**

16       **tivities for the number of hours required each month to satisfy federally required partic-**

17       **ipation rates.**

18       **“(3) If the needy caretaker relatives cease to participate in employment or suitable ac-**

19       **tivities for a sufficient number of hours each month to satisfy federally required partic-**

20       **ipation rates, the department shall determine eligibility under ORS 412.006 based upon**

21       **information available to the department. If the department does not have sufficient infor-**

22       **mation available to determine eligibility for aid under ORS 412.006, the department shall**

23       **provide notice and an opportunity for hearing prior to terminating aid. The notice must state**

24       **the information that the department lacks and that the caretaker relatives must provide to**

25       **complete the determination for aid.**

26       **“(4) The department by rule shall establish standards for aid provided under this section.**

27       **The department must disregard such aid for purposes of publicly subsidized child care as-**

28       **sistance.**

29       **“(5) In addition to money payments, aid includes necessary support service payments and**

30       **services as part of the job opportunity and basic skills program to directly or indirectly assist**

31       **the family in achieving long term financial stability.**

32       **“SECTION 7. The amendments to ORS 412.124 by section 6a of this 2015 Act become op-**

33       **erative on July 1, 2017.**

34       **“SECTION 8.** ORS 411.075 is amended to read:

35       “411.075. (1) There is established the Family Services Review Commission consisting of **no more**

36       **than 16 members.** The members shall be appointed by the Governor for a term of four years. In

37       making the appointments, the Governor shall consider [*representatives of county public welfare*

38       *boards, as well as representatives from all of the congressional districts. Four members shall be re-*

39       *ipients or former recipients of cash or self-sufficiency-related services from the Department of Human*

40       *Services. Four members shall be representatives of business and professional interests. Four members*

41       *shall be public welfare policy specialists. Four members shall be advocates of public welfare from the*

42       *state agencies or public or private organizations interested in public welfare. The commission shall*

43       *receive compensation and expenses as provided in ORS 292.495]* **individuals who are or have par-**

44       **ticipated in programs administered by the Department of Human Services and individuals**

45       **who represent diverse geographic areas, cultural and ethnic perspectives and professional**

1 **experiences. The Governor may appoint members who are employees of the department but**  
2 **such members may not compose more than 25 percent of the membership of the commission**  
3 **or hold a leadership position in the commission.**

4 **“(2) Members of the commission who are not public employees shall receive compen-**  
5 **sation and expenses as provided in ORS 292.495.**

6 “[2] **(3) The commission shall advise and consult with the Director of Human Services [in car-**  
7 **rying out the functions of the department relating to programs and services to persons who, as a result**  
8 **of the person’s or the person’s family’s economic, social or health condition, require medical assistance,**  
9 **financial assistance, institutional care, rehabilitation, vocational rehabilitation or other social or health**  
10 **services.] on all matters affecting the quality of the experience of and the equitable attain-**  
11 **ment of successful outcomes for families and individuals seeking stability and self-sufficiency**  
12 **through participation in the department’s programs.**

13 **“(4) The commission shall, through its chairperson, have access to information [regarding per-**  
14 **sons receiving assistance and other relevant information about self-sufficiency programs of the depart-**  
15 **ment] that is reasonably necessary to carry out the commission’s advisory and consultative**  
16 **functions.**

17 **“SECTION 9.** ORS 411.892 is amended to read:

18 **“411.892. (1)(a) All employers, including public and private sector employers within the State of**  
19 **Oregon, are eligible to participate in the JOBS Plus Program. The Department of Human Services**  
20 **shall adopt by rule a method to disqualify employers from participating in the program. No employer**  
21 **is required to participate in the JOBS Plus Program. In the event that there are unassigned partic-**  
22 **ipants whom no employer desires to utilize, the participants may be assigned to work for a public**  
23 **agency.**

24 **“(b) The maximum number of program participants that any employer is authorized to receive**  
25 **at any one time may not exceed 10 percent of the total number of the employer’s employees. How-**  
26 **ever, each employer may receive one participant. The Director of Human Services may waive the**  
27 **limit in special circumstances.**

28 **“(c) The Department of Human Services by rule shall establish criteria for excluding employers**  
29 **from participation for failure to abide by program requirements, showing a pattern of terminating**  
30 **participants prior to the completion of training or other demonstrated unwillingness to comply with**  
31 **the stated intent of the program.**

32 **“(2) The Department of Human Services shall ensure that jobs made available to program par-**  
33 **ticipants:**

34 **“(a) Do not require work in excess of 40 hours per week;**

35 **“(b) Are not used to displace regular employees or to fill unfilled positions previously estab-**  
36 **lished; and**

37 **“(c) Do not pay a wage that is substantially less than the wage paid for similar jobs in the local**  
38 **economy with appropriate adjustments for experience and training.**

39 **“(3)(a) Eligibility for the program shall be limited to residents who are:**

40 **“(A) Adults and caretaker relatives who are receiving temporary assistance for needy families**  
41 **benefits;**

42 **“(B) Adult Supplemental Nutrition Assistance Program recipients except as described in sub-**  
43 **section (5)(b) of this section; and**

44 **“(C) Unemployed noncaretaker parents of children who are receiving temporary assistance for**  
45 **needy families benefits.**

1 “(b) In addition to those residents eligible for the program under paragraph (a) of this sub-  
2 section, additional residents who are seeking employment may be eligible for the program if there  
3 are legislatively allocated funds available in the temporary assistance for needy families budget of  
4 the Department of Human Services.

5 “(4)(a) Individuals desiring work through the program shall contact the nearest Department of  
6 Human Services office serving the county in which they reside if they are temporary assistance for  
7 needy families program or Supplemental Nutrition Assistance Program applicants or recipients or  
8 noncustodial parents of individuals receiving temporary assistance for needy families.

9 “(b) With the assistance of the local JOBS Plus Implementation Councils and the JOBS Plus  
10 Advisory Board, the Department of Human Services shall develop a job inventory of sufficient size  
11 to accommodate all of the participants who desire to work in the program. In consultation with the  
12 participant, the department shall try to match the profile of each participant with the needs of an  
13 employer when assigning a participant to work with the employer.

14 “(c) Either the employer or the participant may terminate the assignment by contacting the  
15 appropriate Department of Human Services office. In such event, the Department of Human Services  
16 shall reassess the needs of the participant and assign the participant to another JOBS Plus Program  
17 placement or another job opportunity and basic skills program component and, at the employer’s  
18 request, provide the employer with another participant.

19 “(d)(A) If after four months in a placement, a participant has not been hired for an unsubsidized  
20 position, the employer shall allow the worker to undertake eight hours of job search per week.  
21 Participating employers shall consider such time as hours worked for the purposes of paying wages.

22 “(B) If after six months in a placement, a participant has not been hired for an unsubsidized  
23 position, the placement shall be terminated, and the caseworker shall reassess the participant’s  
24 employment development plan.

25 “(e) The Department of Human Services may pay placement and barrier removal payments to  
26 temporary assistance for needy families program and Supplemental Nutrition Assistance Program  
27 participants as necessary to enable participation in the JOBS Plus Program.

28 “(f) The Department of Human Services shall accept eligible volunteers into the program prior  
29 to mandating program participation by eligible persons.

30 “(5)(a) Assignment of participants to available jobs shall be based on a preference schedule de-  
31 veloped by the Department of Human Services. Any temporary assistance for needy families recipi-  
32 ent or supplemental nutrition assistance recipient may volunteer for the program.

33 “(b) The following individuals may not be required to participate in the program:

34 “(A) Recipients under the temporary assistance for needy families program and the Supplemental  
35 Nutrition Assistance Program who are eligible for Supplemental Security Income benefits or other  
36 ongoing state or federal maintenance benefits based on age or disability.

37 “(B) Supplemental nutrition assistance applicants or recipients who are employed full-time or  
38 are college students eligible for supplemental nutrition assistance and enrolled full-time in a com-  
39 munity college or an institution of higher education, or enrolled half-time in a community college  
40 or an institution of higher education and working at least 20 hours per week.

41 “(C) Teenage parents who remain in high school if progressing toward a diploma. Teenage par-  
42 ents not in school are eligible for the JOBS Plus Program.

43 “(c) The Department of Human Services shall provide life skills classes and opportunities to  
44 achieve General Educational Development (GED) certificates to appropriate participants in con-  
45 junction with working in the JOBS Plus Program.

1 “(d) Subject to subsection (7) of this section, temporary assistance for needy families and sup-  
2 plemental nutrition assistance shall be suspended at the end of the calendar month in which an  
3 employer makes the first wage payment to a participant who is a custodial parent in a family that  
4 receives temporary assistance for needy families or to any adult member of a household receiving  
5 supplemental nutrition assistance. Failure of the participant to cooperate with the requirements of  
6 the JOBS Plus Program may result in the participant’s removal, in accordance with rules adopted  
7 by the Department of Human Services, from the JOBS Plus Program and suspension of the  
8 participant’s temporary assistance for needy families grant and supplemental nutrition assistance.  
9 A temporary assistance for needy families and supplemental nutrition assistance recipient who has  
10 been removed from the program for failing to cooperate shall be eligible to reapply to participate  
11 in the program and shall have eligibility for program services determined without regard to the  
12 length of time the person was not participating following removal.

13 “(6)(a) Employers shall pay all participating individuals at least the hourly rate of the Oregon  
14 minimum wage.

15 “(b) Sick leave, holiday and vacation absences shall conform to the individual employer’s rules  
16 for temporary employees.

17 “(c) Group health insurance benefits shall be provided by the employer to program participants  
18 if, and to the extent that, state or federal law requires the employer to provide such benefits.

19 “(d) All persons participating in the JOBS Plus Program shall be considered to be temporary  
20 employees of the individual employer providing the work and shall be entitled only to benefits re-  
21 quired by state or federal law.

22 “(e) Employers shall provide workers’ compensation coverage for each JOBS Plus Program par-  
23 ticipant.

24 “(7) In the event that the net monthly full-time wage paid to a participant would be less than  
25 the level of income from the temporary assistance for needy families program and the supplemental  
26 nutrition assistance amount equivalent that the participant would otherwise receive, the Department  
27 of Human Services shall determine and pay a supplemental payment as necessary to provide the  
28 participant with that level of net income. The department shall determine and pay in advance sup-  
29 plemental payments to participants on a monthly basis as necessary to ensure equivalent net pro-  
30 gram wages. Participants shall be compensated only for time worked.

31 “(8) In addition to and not in lieu of the payments provided for under subsections (6) and (7) of  
32 this section, participants shall be entitled to retain the full child support payments collected by the  
33 Department of Justice.

34 “(9) *[Program participants who are eligible for federally and state funded medical assistance at the*  
35 *time they enter the program shall remain eligible as long as they continue to participate in the*  
36 *program.]* In conformity with existing state day care program regulations, child day care shall be  
37 provided for all program participants who require it.

38 “(10) JOBS Plus Program employers shall:

39 “(a) Endeavor to make JOBS Plus Program placements positive learning and training experi-  
40 ences;

41 “(b) Maintain health, safety and working conditions at or above levels generally acceptable in  
42 the industry and no less than that of comparable jobs of the employer;

43 “(c) Provide on-the-job training to the degree necessary for the participants to perform their  
44 duties;

45 “(d) Recruit volunteer mentors from among their regular employees to assist the participants in

1 becoming oriented to work and the workplace; and

2 “(e) Sign an agreement to abide by all requirements of the program, including the requirement  
3 that the program not supplant existing jobs. All agreements shall include provisions noting the  
4 employer’s responsibility to repay reimbursements in the event the employer violates program rules.  
5 When a professional placement service, professional employment organization or temporary employ-  
6 ment agency is acting as an employer pursuant to subsection (13) of this section, agreements under  
7 this paragraph shall require a three-party agreement between the professional placement service,  
8 professional employment organization or temporary employment agency, the organization where the  
9 participant has been placed to perform services and the State of Oregon. The three-party agreement  
10 shall include provisions requiring that all JOBS Plus reimbursements received by the professional  
11 placement service, professional employment organization or temporary employment agency be cred-  
12 ited to the organization where the participant has been placed to perform services.

13 “(11) Program participant wages shall be subject to federal and state income taxes, Social Se-  
14 curity taxes and unemployment insurance tax or reimbursement as applicable under ORS chapter  
15 657, which shall be withheld and paid in accordance with state and federal law. Supplemental pay-  
16 ments made pursuant to subsection (7) of this section shall not be subject to state income taxes  
17 under ORS chapter 316 and, to the extent allowed by federal law, shall not be subject to federal  
18 income taxes and Social Security taxes.

19 “(12)(a) The Department of Human Services shall reimburse employers for the employers’ share  
20 of Social Security, unemployment insurance and workers’ compensation premiums paid on behalf of  
21 program participants referred to the employer by the Department of Human Services, as well as the  
22 minimum wage earnings paid by the employer to program participants referred to the employer by  
23 the Department of Human Services.

24 “(b) If the Department of Human Services finds that an employer has violated any of the rules  
25 of the JOBS Plus Program, the department:

26 “(A) Shall withhold any amounts due to employers under paragraph (a) of this subsection.

27 “(B) May seek repayment of any amounts paid to employers under paragraph (a) of this sub-  
28 section.

29 “(13) For purposes of this section, ‘employer’ shall include professional placement services, pro-  
30 fessional employment organizations and temporary employment agencies.

31 “**SECTION 10.** ORS 412.001 is amended to read:

32 “412.001. As used in ORS 412.001 to 412.155 and 418.647, unless the context or a specially ap-  
33 plicable statutory definition requires otherwise:

34 “(1) ‘Aid’ means money payments with respect to, or on behalf of, a dependent child or children  
35 and includes:

36 “(a) Money payments to meet the needs of the **caretaker** relative with whom the child is living  
37 and the spouse of the **caretaker** relative if the spouse lives with the **caretaker** relative, *the relative*  
38 *is the child’s parent and the child is a dependent child by reason of the physical or mental incapacity,*  
39 *or the unemployment or underemployment, of a parent]; or*

40 “(b) Payments made to a representative payee or guardian pursuant to ORS 412.026 or 412.028.

41 “(2) ‘Caretaker relative’ means a dependent child’s [*father, mother, grandfather, grandmother,*  
42 *brother, sister, stepfather, stepmother, stepbrother, stepsister, uncle, aunt, first cousin, nephew or*  
43 *niece]* **parent or other relative by blood, marriage or adoption, as defined by the Department**  
44 **of Human Services by rule**, who lives in a residence maintained by one or more of the relatives  
45 as the child’s or the relative’s own home.

1 “(3)(a) ‘Dependent child’ means a needy child:  
2 “[*(A)* *Who has been deprived of parental support or care by reason of the death, continued absence*  
3 *from the home or physical or mental incapacity, or unemployment or underemployment, of a parent;*]  
4 “[*(B)*] **(A)** Whose caretaker relatives are not able to provide adequate care and support for the  
5 child without public assistance, as defined in ORS 411.010;  
6 “[*(C)*] **(B)** Who lives with a caretaker relative; and  
7 “[*(D)*] **(C)** Who meets the requirements of paragraph (b) of this subsection.  
8 “(b)(A) Except as provided in subparagraphs (B) and (C) of this paragraph, a ‘dependent child’  
9 must be under the age of 18 years.  
10 “(B) A child may qualify as a ‘dependent child,’ subject to the availability of funds, if the child  
11 is 18 or 19 or 20 years of age and a student regularly attending a school in grade 12 or below or  
12 regularly attending a course of professional or technical training designed to fit the child for gainful  
13 employment, other than a course provided by or through a college or university.  
14 “(C) Students under the age of 21 years and regularly attending a school, college or university  
15 or regularly attending a course of professional or technical training designed to fit the child for  
16 gainful employment may be included in the description in subparagraph (B) of this paragraph at the  
17 option of the Department of Human Services.  
18 “(4) ‘Federally required participation rates’ means the participation rates as required by section  
19 407 of the Social Security Act.  
20 “(5) ‘Representative payee’ means an individual designated by the department to receive money  
21 payments of aid pursuant to ORS 412.026.  
22 “**SECTION 11.** ORS 412.006 is amended to read:  
23 “412.006. (1) Aid pursuant to the temporary assistance for needy families program shall be  
24 granted under this section to [*any dependent child who is living in a home meeting the standards of*  
25 *care and health fixed by the rules of the Department of Human Services and who is a resident of the*  
26 *State of Oregon, if a parent or caretaker relative with whom the child is living is a resident of the State*  
27 *of Oregon*] **families with dependent children residing in this state.**  
28 “(2) Except as provided in subsections **(6) and (7)** [*and (8)*] of this section, a needy caretaker  
29 relative may be required to participate in the job opportunity and basic skills program that is de-  
30 scribed in subsections (3) to [*(6)*] **(5)** of this section.  
31 “(3) The department shall use a basic assessment tool to determine if a needy caretaker relative  
32 applying for or receiving aid under this section has or may have a barrier to employment or to  
33 family stability. If the basic assessment tool indicates that there is or may be a barrier, the needy  
34 caretaker relative shall be referred for an in-depth assessment by a person with relevant expertise  
35 or specialized training.  
36 “(4) Based upon the assessment described in subsection (3) of this section, the department, in  
37 cooperation with appropriate partner agencies or professionals, [*shall*] **may** work with the partic-  
38 ipant to create an effective individualized case plan that establishes goals and identifies suitable  
39 activities that promote family stability and financial independence.  
40 “[*(5)* *Suitable activities may include:*]  
41 “[*(a)* *Job readiness activities or employment;*]  
42 “[*(b)* *Vocational rehabilitation or training;*]  
43 “[*(c)* *Remedial, secondary or post-secondary education;*]  
44 “[*(d)* *Community service; or*]  
45 “[*(e)* *Other activities that reduce or eliminate barriers to full participation in the program or to*



1 *employment.]*

2 “[(6)] (5) For individuals with disabilities, the goal of the individualized case plan must be to  
3 promote greater independence *[and may include physical or mental health evaluation or treatment].*

4 “[(7)] (6) A needy caretaker relative receiving aid under ORS 412.001 to 412.069 may volunteer  
5 for but may not be required to participate in the job opportunity and basic skills program:

6 “(a) More than 10 hours per week during the first two months of the third trimester of the  
7 parent’s pregnancy;

7 in accordance with the standards established by the Oregon Health Authority under ORS 414.655  
8 and that incorporates the following core attributes:

9 “(a) Access to care;

10 “(b) Accountability to consumers and to the community;

11 “(c) Comprehensive whole person care;

12 “(d) Continuity of care;

13 “(e) Coordination and integration of care; and

14 “(f) Person and family centered care.

15 “(13) ‘Peer wellness specialist’ means an individual who is responsible for assessing mental  
16 health service and support needs of the individual’s peers through community outreach, assisting  
17 individuals with access to available services and resources, addressing barriers to services and  
18 providing education and information about available resources and mental health issues in order to  
19 reduce stigmas and discrimination toward consumers of mental health services and to provide direct  
20 services to assist individuals in creating and maintaining recovery, health and wellness.

21 “(14) ‘Person centered care’ means care that:

22 “(a) Reflects the individual patient’s strengths and preferences;

23 “(b) Reflects the clinical needs of the patient as identified through an individualized assessment;  
24 and

25 “(c) Is based upon the patient’s goals and will assist the patient in achieving the goals.

26 “(15) ‘Personal health navigator’ means an individual who provides information, assistance, tools  
27 and support to enable a patient to make the best health care decisions in the patient’s particular  
28 circumstances and in light of the patient’s needs, lifestyle, combination of conditions and desired  
29 outcomes.

30 “(16) ‘Quality measure’ means the measures and benchmarks identified by the authority in ac-  
31 cordance with ORS 414.638.

32 “(17) ‘Resources’ has the meaning given that term in ORS 411.704. For eligibility purposes, ‘re-  
33 sources’ does not include charitable contributions raised by a community to assist with medical ex-  
34 penses.

35 “**SECTION 26.** ORS 411.635 is amended to read:

36 “411.635. (1)(a) Medical assistance improperly disbursed as a result of recipient conduct that is  
37 not in violation of ORS 411.630 may be recouped pursuant to ORS 293.250 by the Oregon Health  
38 Authority or the Department of Human Services.

39 “(b) Public assistance improperly disbursed as a result of recipient conduct that is not in vio-  
40 lation of ORS 411.630 may be recouped pursuant to ORS 293.250 by the department.

41 “(2) The department and the authority may also recoup public assistance and medical assistance  
42 improperly disbursed from earnings that the state disregards pursuant to ORS 411.083 and [412.009]  
43 **section 4 of this 2015 Act** as follows:

44 “(a) The department and the authority shall notify the recipient that the recipient may elect to  
45 limit the recoupment monthly to an amount equal to one-half the amount of disregarded earnings

1 by granting the department or the authority a confession of judgment for the amount of the over-  
2 payment.

3 “(b) If the recipient does not elect to grant the confession of judgment within 30 days the de-  
4 partment or the authority may recoup the overpayment from the entire amount of disregarded  
5 earnings. The recipient may at any time thereafter elect to limit the monthly recoupment to one-half  
6 the disregarded earnings by entering into a confession of judgment.

7 “(3) The department and the authority shall not execute on a confession of judgment until the  
8 recipient is no longer receiving public assistance or medical assistance and has either refused to  
9 agree to or has defaulted on a reasonable plan to satisfy the judgment.

10 “(4) This section does not prohibit the department or the authority from adopting rules to ex-  
11 empt from recoupment any portion of disregarded earnings.

12 “**SECTION 26a.** ORS 411.175 is amended to read:

13 “411.175. (1) In addition to any other scholarships or grants provided by law and subject to the  
14 availability of funds in the Department of Human Services Scholarship Account, the Department of  
15 Human Services may award tuition and fee-exempting scholarships or grants and additional funds  
16 for purchase of required books and supplies from other funds, whether from public or private  
17 sources, made available for training of recipients toward self-support to those qualified to receive  
18 welfare assistance, for enrollment at any publicly supported educational, vocational or training in-  
19 stitution in this state.

20 “[2] *Selection of scholarship or grant recipients shall be made by county public welfare board*  
21 *created by ORS 411.077, with the advice and assistance of all publicly supported educational, voca-*  
22 *tional or training institutions.]*

23 “[3] (2) Scholarships or grants shall be awarded on the basis of the recipient’s apparent ability  
24 and willingness to profit from the education or the vocational, technical, or other courses available,  
25 to the end that scholarships or grants awarded will benefit both the student and the people of this  
26 state.

27 “[4] (3) In order to facilitate the most effective use of funds granted under this section, the  
28 Department of Human Services may apply funds available under this section to supportive services,  
29 including but not limited to transportation and child care, for scholarship or grant recipients  
30 whenever the availability of such services has been eliminated by the exhaustion of funds in the  
31 department’s job related training program.

32 “**SECTION 26b.** ORS 412.991 is amended to read:

33 “412.991. A person who violates ORS 412.074 [or 412.099 (1)] commits a Class A misdemeanor.

34 “**SECTION 27. Sections 1, 2 and 5 of this 2015 Act and ORS 412.016 and 412.017 are added**  
35 **to and made a part of ORS chapter 412.**

36 “**SECTION 28. (1) ORS 411.077, 411.078, 412.076, 412.099, 412.104 and 412.114 are repealed.**

37 “**(2) Section 26, chapter 722, Oregon Laws 2013, is repealed.**

38 “**(3) Section 3 of this 2015 Act is repealed on June 30, 2017.**

39 “**SECTION 29. Section 4 of this 2015 Act and the amendments to ORS 411.635, 412.001,**  
40 **412.009 and 412.079 by sections 10, 12, 19 and 26 of this 2015 Act become operative on April**  
41 **1, 2016.**

42 “**SECTION 30. This 2015 Act being necessary for the immediate preservation of the public**  
43 **peace, health and safety, an emergency is declared to exist, and this 2015 Act takes effect**  
44 **on its passage.”**
