**PROPOSED AMENDMENTS TO
B-ENGROSSED SENATE BILL 243**

1 On page 1 of the printed B-engrossed bill, line 2, after “166.377” delete the
2 rest of the line and delete line 3 and insert “and sections 10 and 13, chapter
3 1, Oregon Laws 2023; and declaring an emergency.”.

4 On page 5, delete lines 28 through 38 and insert:

8 **“SECTION 6.** Section 10, chapter 1, Oregon Laws 2023, is amended to
9 read:

10 **“Sec. 10. ORS 166.503, 166.505 and 166.508 and** the amendments to ORS
11 166.412, 166.435, 166.436 and 166.438 by sections [3] **6 to 9, [of this 2022 Act]**
12 **chapter 1, Oregon Laws 2023,** apply to firearm transfers conducted on or
13 after [*the effective date of this 2022 Act*] **March 15, 2026.**

14 **“SECTION 7.** Section 13, chapter 1, Oregon Laws 2023, is amended to
15 read:

16 **“Sec. 13.** The provisions of [*this 2022 Act*] **ORS 166.355** apply to [*all*
17 *actions taken on or after the effective date of this 2022 Act, unless expressly*
18 *stated otherwise herein. This 2022 Act may be known and cited as the Re-*
19 *duction of Gun Violence Act*] **the manufacture, importation, possession,**
20 **use, purchase, sale or transfer of a large-capacity magazine occurring**
21 **on or after March 15, 2026.**

3 **“SECTION 8. Sections 1 and 2 of this 2025 Act and the amendments**
4 **to ORS 166.262, 166.370 and 166.377 by sections 3 to 5 of this 2025 Act**
5 **become operative on the 91st day after the date on which the 2025**
6 **regular session of the Eighty-third Legislative Assembly adjourns sine**
7 **die.**

18 **“SECTION 10. This 2025 Act being necessary for the immediate**
19 **preservation of the public peace, health and safety, an emergency is**
20 **declared to exist, and this 2025 Act takes effect on its passage.”.**
