## RESOLUTION

Establishing the Select Committee on Gun Violence  
Prevention.

1       *Resolved,*

2       **SECTION 1. ESTABLISHMENT.**

3           There is hereby established the Select Committee on  
4 Gun Violence Prevention (hereafter referred to as the “Se-  
5 lect Committee”).

6       **SEC. 2. COMPOSITION.**

7           (a) COMPOSITION.—The Select Committee shall be  
8 composed of 12 Members appointed by the Speaker, of  
9 whom 6 shall be appointed after consultation with the Mi-  
10 nority Leader.

11          (b) CHAIR AND RANKING MINORITY MEMBER.—The  
12 Speaker shall designate one Member to serve as chair of  
13 the Select Committee, and the Minority Leader shall des-  
14 ignate one Member to serve as ranking minority member  
15 of the Select Committee.

16          (c) VACANCIES.—Any vacancy in the Select Com-  
17 mittee shall be filled in the same manner as the original  
18 appointment.

1 **SEC. 3. DUTIES.**

2 (a) INVESTIGATION AND STUDY.—The Select Com-  
3 mittee is authorized and directed to conduct a full and  
4 complete investigation and study, and to issue a report  
5 of its findings to the House, regarding each of the fol-  
6 lowing:

7 (1) The causes of mass shootings.

8 (2) Methods to improve the Federal firearms  
9 purchaser background check system.

10 (3) Connections between access to firearms and  
11 dangerously mentally ill individuals.

12 (4) Strengthening Federal penalties for traf-  
13 ficking and straw purchasing of firearms.

14 (5) Closing loopholes that allow some domestic  
15 abusers continued access to firearms.

16 (6) Linkages between firearms and suicide.

17 (7) Gun violence's effect on public health.

18 (8) The correlation between State gun violence  
19 prevention laws and the incidence of gun violence.

20 (9) The importance of having reliable and accu-  
21 rate information on gun violence and its toll on our  
22 Nation.

23 (10) The implementation of effective gun vio-  
24 lence prevention laws in accordance with the Second  
25 Amendment to the Constitution.

1           (11) Rates of gun violence in large metropolitan  
2           areas.

3           (b) HEARINGS.—In carrying out its duties under sub-  
4           section (a), the Select Committee shall hold at least one  
5           public hearing in the District of Columbia and at least  
6           two public hearings in locations outside of the District of  
7           Columbia.

8           **SEC. 4. RULES AND PROCEDURES.**

9           Rule XI of the Rules of the House of Representatives  
10          shall apply to the Select Committee in the same manner  
11          as such Rule applies to a standing committee of the  
12          House, except to the extent inconsistent with this resolu-  
13          tion.

14          **SEC. 5. STAFF; FUNDING.**

15          (a) STAFF.—The chair of the Select Committee, upon  
16          consultation with the ranking minority member of the Se-  
17          lect Committee, may employ and fix the compensation of  
18          such staff as the chair considers necessary to carry out  
19          this resolution.

20          (b) FUNDING.—There shall be paid out of the appli-  
21          cable accounts of the House of Representatives such sums  
22          as may be necessary for the expenses of the Select Com-  
23          mittee. Such payments shall be made on vouchers signed  
24          by the chair of the Select Committee and approved in the  
25          manner directed by the Committee on House Administra-

1 tion. Amounts made available under this subsection shall  
2 be expended in accordance with regulations prescribed by  
3 the Committee on House Administration.

4 **SEC. 6. RECOMMENDATIONS.**

5 (a) **FINAL REPORT.**—The Select Committee shall  
6 issue a final report and recommendations, including legis-  
7 lative proposals, not later than 60 days after the date of  
8 the adoption of this resolution.

9 (b) **INTERIM FINDINGS AND REPORTS.**—In addition  
10 to the final report and recommendations required under  
11 subsection (a), the Select Committee may issue such in-  
12 terim findings and reports as it deems necessary.

13 **SEC. 7. TERMINATION.**

14 (a) **IN GENERAL.**—The Select Committee and all au-  
15 thority granted in this resolution shall expire upon the  
16 issuance by the Select Committee of the final report and  
17 recommendations under section 6(a).

18 (b) **RECORDS.**—Upon the dissolution of the Select  
19 Committee, the records, files, and materials of the Select  
20 Committee shall be transferred to the Clerk of the House.
