11 question shall be considered as ordered on the joint resolu-
12 tion and on any amendment thereto to final passage with-
13 out intervening motion except: (1) one hour of debate
14 equally divided and controlled by the chair and ranking
15 minority member of the Committee on Financial Services;
16 and (2) one motion to recommit.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to consider in the House the joint resolution (H.J.
19 Res. 40) providing for congressional disapproval under
20 chapter 8 of title 5, United States Code, of the rule sub-
21 mitted by the Social Security Administration relating to
22 Implementation of the NICS Improvement Amendments
23 Act of 2007. All points of order against consideration of

1 the joint resolution are waived. The joint resolution shall
2 be considered as read. All points of order against provi-
3 sions in the joint resolution are waived. The previous ques-
4 tion shall be considered as ordered on the joint resolution
5 and on any amendment thereto to final passage without
6 intervening motion except: (1) one hour of debate equally
7 divided and controlled by the chair and ranking minority
8 member of the Committee on the Judiciary or their respec-
9 tive designees; and (2) one motion to recommit.
