## A BILL

To amend title 18, United States Code, to discontinue the collection by the Federal Government of firearm transaction records of discontinued firearms businesses, to require the destruction of such already collected records, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “No Retaining Every  
3 Gun In a System That Restricts Your Rights Act”.

4 **SEC. 2. DESTRUCTION OF BUREAU OF ALCOHOL, TOBACCO,  
5 FIREARMS, AND EXPLOSIVES FIREARM  
6 TRANSACTION RECORDS OF DISCONTINUED  
7 FIREARMS BUSINESSES.**

8 (a) IN GENERAL.—Within 90 days after the date of  
9 the enactment of this Act, the Director of the Bureau of  
10 Alcohol, Tobacco, Firearms, and Explosives shall destroy  
11 all firearm transaction records delivered to the Attorney  
12 General pursuant to section 923(g)(4) of title 18, United  
13 States Code.

14 (b) PREVENTING FUTURE FIREARM REGISTRA-  
15 TION.—Section 923(g)(4) of title 18, United States Code,  
16 is amended by striking the 2nd and 3rd sentences.

17 **SEC. 3. REPORT TO THE CONGRESS.**

18 The Director of the Bureau of Alcohol, Tobacco,  
19 Firearms, and Explosives shall submit to the Congress a  
20 written report that specifies the number of firearm trans-  
21 action records destroyed pursuant to section 2(a).
