7	Statement of purpose of bill as introduced: This bill proposes to prohibit the
8	possession of firearms and dangerous weapons in State buildings and on State
9	land.
10 11	An act relating to prohibiting possession of firearms and dangerous weapons in State buildings and on State land
12	It is hereby enacted by the General Assembly of the State of Vermont:
13	Sec. 1. 13 V.S.A. § 4028 is added to read
14	<u>§ 4028. POSSESSION OF FIREARMS AND DANGEROUS WEAPONS IN</u>
15	STATE BUILDINGS AND ON STATE LAND PROHIBITED
16	(a) A person shall not knowingly possess a firearm or dangerous weapon in
17	a State building or on State land.
18	(b)(1) A person who violates subsection (a) of this section shall be
19	imprisoned for not more than one year or fined not more than \$2,000.00, or
20	both.

1	(2) A person who violates subsection (a) of this section with the intent to
2	use the firearm or dangerous weapon to commit a crime shall be imprisoned
3	for not more than five years or fined not more than \$10,000.00, or both.
4	(c) This section shall not apply to:
5	(1) a firearm or dangerous weapon carried for legitimate law
6	enforcement purposes by a federal law enforcement officer or a law
7	enforcement officer certified as a law enforcement officer by the Vermont
8	Criminal Justice Council pursuant to 20 V.S.A. § 2358;
9	(2) a firearm or dangerous weapon carried by a person while preforming
10	the person's official duties as an employee of the United States; a department
11	or agency of the United States; a state; or a department, agency, or political
12	subdivision of a state if the person is authorized to carry a firearm or dangerous
13	weapon as part of the person's official duties;
14	(3) a firearm or dangerous weapon carried by a member of the Vermont
15	National Guard, of the National Guard of another state, or of the U.S. Armed
16	Forces who is on duty and acting under state or federal orders;
17	(4) buildings or land or portions of buildings or land that are:
18	(A) owned or leased by the Department of Buildings and General
19	Services; and
20	(B) leased or subleased by the Department of Buildings and General
21	Services to private tenants for their exclusive use;

1	(5) a sidewalk along the street frontage of State property that falls within
2	the property lines of the State property and is not physically distinguishable
3	from adjacent public sidewalks, and any paved area adjacent to and not
4	physically distinguishable from such a sidewalk;
5	(6) the lawful carrying of a firearm or dangerous weapon into a State
6	building or onto State land for a purpose authorized in advance by the
7	Department of Buildings and General Services or by the tenant agency
8	occupying or using the building or land;
9	(7) a firearm or dangerous weapon carried by an instructor, educator, or
10	participant in an educational or training class conducted by an agency or entity
11	of State government while engaging in the educational or training class or
12	activity, including the Agency of Natural Resources, the Department of Fish
13	and Wildlife, the Vermont Criminal Justice Council, and any other State
14	agency or entity that as part of its mission requires the use of firearms or other
15	dangerous weapons; or
16	(8) a firearm or dangerous weapon carried by a person incident to lawful
17	activities, including hunting, on State-owned or State-leased lands if the person
18	is licensed as required by law and is otherwise in compliance with all appliable
19	federal, State, and municipal laws and rules, including regulations promulgated
20	by the Fish and Wildlife Board.
21	(d) As used in this section:

1	(1) "Dangerous or deadly weapon" means a weapon, device, instrument,
2	material, or substance, whether animate or inanimate, that is used or readily
3	capable of being used to cause death or serious bodily injury, including an
4	explosive as defined in section 1603 of this title, except that "dangerous or
5	deadly weapon" does not include a pocket knife with a blade of less than 2.5
6	inches in length.
7	(2) "Firearm" has the same meaning as in subsection 4017(d) of this title.
8	(3) "State building" means a building or part of a building owned or
9	leased by the Department of Buildings and General Services where State
10	employees are regularly present for the purpose of performing their official
11	duties and includes all owned or leased State buildings, structures, and
12	appurtenances under the jurisdiction of the Commissioner of Buildings and
13	General Services except as provided in 29 V.S.A. § 152(a)(9) and 29 V.S.A.
14	chapter 5A.
15	(4) "State land" means all State-owned or State-leased land and grounds
16	under the jurisdiction of the Commissioner of Buildings and General Services
17	except as provided in 29 V.S.A. § 152(a)(9) and 29 V.S.A. chapter 5A.
